Dear Contractor:

This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN YOLO AND SACRAMENTO COUNTIES IN WEST SACRAMENTO AND SACRAMENTO AT SACRAMENTO RIVER BRIDGE to revise the *Notice to Bidders and Special Provisions*.

Submit bids for this work with the understanding and full consideration of this addendum. The revisions declared in this addendum are an essential part of the contract.

Bids for this work will be opened on Tuesday, April 24, 2018.

In the Special Provisions, Section 12-3.32C, the first paragraph is replaced as follows:

"Place PCMSs at the locations shown and in advance of the 1st warning sign at least 14 days prior to construction for each:

1. Stationary lane closure
2. Shoulder closure"

In the Special Provisions, Section 12-4.02A(2), the paragraph is replaced as follows:

"No detours, lane closures, ramp closures, shoulder closures, or other traffic restrictions will be allowed during the following events:

1. Tour of California Bike Race
2. The Sacramento Jazz Jubilee
3. The Pacific Rim Festival
4. Mardi Gras Days
5. Farm-To-Fork Festival"
